PUNXSUTAWNEY - Cancer is a disease that has continued to affect many over the years. It is a disease that strikes without warning and affects those of all ages. Sadly, there is no cure, but those at the cancer research centers are determined to find one.

Wanting to make a difference for

those fighting cancer, local native Mark Gagliardi decided to use his passion for shooting to help raise money not only for cancer research, but also for other charitable organiza-

It began in 2003, when Gagliardi was pheasant hunting in California, alongside some union representa-

# VOLUNTEERS MAKE TAX SEASON LESS TAXING, STRESSFUL



Community Action, Inc. and The Jefferson County Area Agency on Aging honored volunteers who served over 2,000 hours as Volunteer Income Tax Assistance (VITA) preparers in Clarion and Jefferson counties. This tax season, 1,387 returns were successfully e-filed, bringing federal refunds and Earned Income Tax Credits totaling \$1,050,213 into local communities. The VITA Program offered free tax help to families earning \$52,000 or less. All volunteers received free training and were certified by the Internal Revenue Service (IRS). ANITA — Brenda Scarantine is a familiar face. You may recognize her as the treasurer for the American Legion Auxiliary Unit No. 62 who recently helped her organization sell poppies. Or perhaps you have seen her throughout the community.

Scarantine was born in Buffalo, New York, and raised in Punxsutawney. She is a 1970 graduate of Punxsutawney Area High School.

After graduation, she married her husband, Jim, and was a stay-athome mother until 1977.

In 1977, Scarantine joined the workforce and obtained a position at the former Murphy Mart, which later became the former Ames store.

She stayed on when the store became Ames and worked as the personnel director/trainer.

"I did a little bit of everything. I went out to other stores and trained people. I was the district trainer for Ames," she said.

In 1999, Scarantine traveled to Pittsburgh and helped convert the former Hills store into an Ames.

Much to her dismay, in 2002, Ames closed its doors for good.

"I really enjoyed working for Ames. I really miss the people I met, and I just loved working with the associates," she added.

After Ames closed, her sister opened a quilt shop in Reynoldsville, which Scarantine helped run.

It was around that time that she was asked by the Democratic commissioner to run for the county auditor seat. She took a chance, ran for the seat and won.

Scarantine explained that as county auditor, she does auditing and checks and settles the accounts of the row offices.

#### Maintenance building remains hot topic for school board

PUNXSUTAWNEY At Wednesday night's school board meeting, one of the major topics of discussion was the maintenance building.

With the proposal from KTH not being approved, board member Jim Baun presented a set of blueprints from another company for the board to take a look at.

Baun stated that the building would cost less money than what KTH wants to charge.

He went on to discuss the figures and estimates for how much the building materials would cost, coming up with the following: All materials, he estimated, would cost \$78,555; labor would cost

\$86,000; and if they choose to go with in-floor heat, that will cost \$20,000.

In his opinion, Baun believes that a building can be constructed for \$170,000.

He went on to add that

the building in the blueprint he presented was constructed for \$200,000. A motion was made to

approve the blueprints, with it being approved in a 5-2

Voting no were board President Bob Pascuzzo and board member Ed McGinnis.

Pascuzzo and board solicitor Dave Young expressed their opinions that it is not a wise decision.

Pascuzzo reminded Baun that he is just a board member and can not oversee the construction of the building.
